


4. Educate the children youth & women to be liable to take the challenge and work for the protection of God's mighty creation.



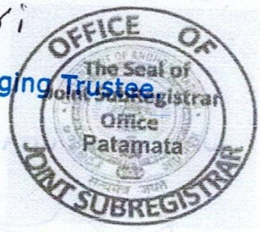

- f) To establish, assist and take over the management of Educational institutions with similar views.

27. To empower women in several ways, including accepting women's view points, making an effort to seek them and rising the status of women through education, awareness, literacy and training.



DAMMALAPATI LAKSHMI RAJU, shall be the convener of the meetings of the trust and shall carrying out or implement the decisions of the board. The meeting of the board of trustees shall be held at least once in quarter of convene the meetings of trustees at any time on occasion demands. In case of emergency a meeting may be convened at any shorter notice. The Board of Trustees shall meet at least once in every financial year at which yearly accounts of the trust and reports of the auditors shall be present.

The quorum for the Board of Meetings shall be 2/3rds the total strength ignoring the fraction. The decision of the majority of trustees present at a meeting shall be begining on all members In case of equal votes the managing trustee shall have the casting vote.

Subject to the supervision and control of the Board and subject to the express provisions herein contained, the Managing Trustee for the time being of the trust shall have all and every power for the purpose of Managing, conducting and controlling and administrating the affairs of all institutions and establishments created and managed by the trust.


The sole Trustee Cum managing Trustee for the being of the Trust shall arrange for the maintenance of correct and proper accounts and proper accounts of the receipts and disbursements and the liability incurred and of the assets acquired and for an Audit of the accounts of the trust and the income and expenditure relating thereto.

The managing Trustee shall cause to close the books of accounts of the trust in every year as on 31st day of March, and cause an Income and Expenditure accounts of the year ending with 31st March and balance sheet on the date to be prepared.

The sole Trustee shall appoint a chartered accountant to audit the accounts of the Trust for every year and the Chartered Accountant shall make a report to the Board on the accounts examined and submit balance sheet.


The board shall have power to borrow, raise, secure money and funds from banks or other persons as the board may deem fit for the purpose of establishing or acquiring immovable properties etc., or to take any property for lease and create charges and pay off such borrowing from the future income or gifts.

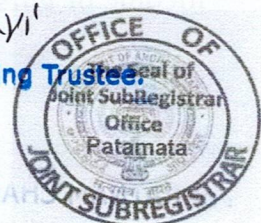

The sole trustee cum Managing Trustee shall be the Executive Officer of the Board, and as such, he shall have power and authority for and on behalf of the board.



The managing Trust and the other Trustee may reimburse themselves or pay or reimburse out of the trust moneys in their hands all expenses property incurred by them in or about the execution of the trust objects and in discharge of the duties imposed on them under this trust.






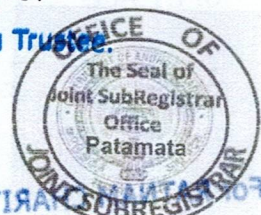

If any time, the objects of the trust should become impossible of fulfillment, the properties and funds belonging to the trust shall be paid or transferred to any other institutions having similar aims and objects and registered with the commissioner of Income Tax, under section 12A of Income Tax Act after satisfying all liabilities standing on the day.

To start financial assistance for the use of the trust, to establish educational institutions and other social activities, to issue / Merit scholarships to the poor people irrespective their affiliation like religion, caste, etc., to give self employment training to the educated unemployed unit. To promote activities for school children such as traffic awareness, environmental and political sciences.

MANAGING TRUSTEE :

Hereinafter referred to as life time sole trustee till he (Sole Trustee) voluntarily takes retirement or resigns as a sole trustee. He shall be the officer to sue or sued on behalf of the Trust. He will have a power to control, manage and supervise the administration of the Trust.

TREASURER:

Treasurer shall be elected by the General Body of the trust once in three years. He will prepare and submit annual balance sheet of the receipts and payments duly audited by an auditor. He will perform the duties with guidance of the Managing Trustee

BOARD OF TRUSTEES:

The meetings of the board of the trustees shall be held at least on occasions according to the needs. Minimum three days notice shall be given to convince the meetings of trustees. In case of emergency a meeting may be convened at any shorter notice. The Board of Trustees shall meet at least once in every financial year at which the yearly accounts of the trust and reports of the auditors shall be present.

FILLING OF VACANCIES:

If any vacancy in the board of Trustees of death or other contingencies a member acceptable to the board of Trustees shall be co opted by the board of trustees.



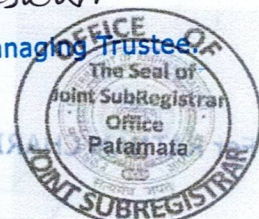

CORRESPONDENT :




